Essex Street, thence continuing in a northerly direction for a distance of 22 feet.
- B. On South Warren Street. Said Taxi Stand shall be located along the westerly curb line of S. Warren Street beginning at a point 34 feet south of the southwesterly curb line intersection of E. Blackwell Street and S. Warren Street, thence continuing in a southerly direction for distance of 23 feet.

### Section 2

The balance of Ordinance 20-2007 shall remain in full force and effect

### Section 3

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistencies.

### Section 4

If any article, section, subsection, paragraph, phrase or sentence is, for any reason, held to be unconstitutional or invalid, said article, section, subsection, paragraph, phrase or sentence shall be deemed severable.

### RESOLUTION NO. 223-2019

RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER AUTHORIZING THE AWARD OF A CONTRACT BY SEALED BID TO INTERCONTINENTAL CONSTRUCTION CONTRACTING, INC. FOR THE NEW MUNICIPAL BUILDING: RENOVATION & RESTORATION PROJECT IN THE AMOUNT OF \$9,386,100

WHEREAS, on August 7, 2019, the Town of Dover opened sealed bids for the New Municipal Building Project; and

WHEREAS, the Town of Dover received two (2) bids from the following contractors:

- 1. A.B. Designs Contracting Corp. ("A.B. Designs"); and
- 2. Intercontinental Construction Contracting, Inc. ("ICCI")

WHEREAS, pursuant to the bid specifications, the bid proposals and the prices submitted by the bidders were required to remain open for a period of sixty (60) days which was due to expire on October 7, 2019; and

WHEREAS, the Town of Dover has requested and both bidders have consented to hold their bid amounts open for an additional thirty (30) days; and

WHEREAS, the Town of Dover received a bid protest from ICCI contending that the apparent lowest numerical bid of A.B. Designs was defective in that it's Bid Proposal Form was not fully completed and contained inconsistencies which require its rejection;

WHEREAS, a review of the A.B. Designs' bid revealed that the Bid Proposal Form submitted by A.B. Designs contained two (2) different prices for the "Total Lump Sum Bid Amount" and failed to include a price for the "Total Base Bid";

WHEREAS, the second lowest numerical bid was submitted by ICCI, with a Total Lump Sum Bid Amount of Nine Million Three Hundred Eighty-Six Thousand One Hundred Dollars (\$9,386,100.00), which amount includes project allowances of Five Hundred Twenty-Five Thousand Dollars (\$525,000.00);

WHEREAS, the Board has determined to reject the bid of A.B. Designs as defective, non-conforming and nonresponsive and also determined that ICCI to be the lowest responsive and responsible bidder; and

WHEREAS, the appropriate Town Officials have certified the sufficiency of funds for the award of contract for the New Municipal Building Project; now, therefore, be it

**RESOLVED** that the Town of Dover hereby rejects the bid submitted by A.B. Designs as materially defective, non-conforming and nonresponsive for the failure to fully complete the Bid Proposal Form and due to the fact that it contained two (2) different prices for the "Total Lump Sum Bid Amount"; and be it further

**RESOLVED** that pursuant to *N.J.S.A.* 40A:11-1, *et seq.*, the Town of Dover hereby awards the New Municipal Building Project Contract to Intercontinental Construction Contracting, Inc., 180 Lexington Avenue, 2<sup>nd</sup> Floor, Passaic, NJ, 07055, as the lowest responsive and responsible bidder, in the amount of Nine Million Three Hundred Eighty-Six Thousand One Hundred Dollars (\$9,386,100.00), which amount includes project allowances of Five Hundred Twenty-Five Thousand Dollars (\$525,000.00); and be it further

**RESOLVED** that the Town of Dover authorizes Town Officials and/or employees to take all necessary actions to effectuate the within Resolution including but not limited to the execution of contract documents and for the return the of the bid bond to A.B. Designs.

WHEREAS, the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1, et seq., as amended and supplemented, proves a process for municipalities to participate in the redevelopment and improvement of parcel(s) of property designated as "areas in need of redevelopment"; and

WHEREAS, on October 28, 2014 the Board of Alderman of the Town of Dover (the "Town") by Resolution No. 2014-245 designated certain parcels of property, identified as Block 1208 Lot 7, located within the Town as "an area in need of redevelopment (the "Property"); and

WHEREAS, the Town and Meridia, Campus Center Urban Renewal, Dover, LLC (the "Redeveloper") entered into a redevelopment agreement for the Property (the "Agreement"); and

WHEREAS, the Redeveloper commenced renovation of the existing building and construction of retail space in the first floor and nine (9) residential units on second, third and fourth floor with a first-floor façade improvement; and

WHEREAS, the Redeveloper completed construction of the Project and obtained certificates of compliance and occupancy as required from the Town and has provided a certification that the Project has been completed in conformance with the Agreement; and

WHEREAS, in accordance with the Agreement, the Redeveloper has requested the issuance of a Certificate of Completion for the Project and the Town has agreed to the same in accordance with the terms of this resolution and in the Certificate of Completion; and

**NOW, THEREFORE, BE IT RESOLVED,** by the Mayor and Board of Aldermen of the Town of Dover, that it hereby authorizes the issuance and execution of a Certificate of Completion for the property known as Block 1208, Lot 7 as shown on the Tax Map of the Town of Dover, Morris County, New Jersey with an address of 15 E. Blackwell Street, Dover. New Jersey.

**BE IT FURTHER RESOLVED** that the Mayor and the Town Clerk are hereby authorized to execute any documents in furtherance of this resolution, including the Certificate of Completion, in a form substantially consistent with that attached hereto.

BE IT FURTHER RESOLVED, that this resolution shall take effect immediately.

WHEREAS, the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1, et seq., as amended and supplemented, provides a process for municipalities to participate in the redevelopment of parcel (s) of property designated as "areas in need of redevelopment"; and

WHEREAS, on October 28, 2014 the Board of Aldermen of the Town of Dover (the "Town") by Resolution No. 2014-245 designated certain parcels of property, identified as Block 1208, Lot 7, located within the Town as "an area in need of redevelopment (the "Redevelopment Area"); and

WHEREAS, on December 16, 2014, the Town enacted Ordinance #26-2014 adopting the Redevelopment Plan dated November 4, 2014 (the "Redevelopment Plan") and which sets forth, inter alia, the plan for the redevelopment of the Redevelopment Area and a listing of the goals and objectives to be achieved through the Redevelopment Plan; and

WHEREAS, on August 25, 2015 the Board of Aldermen of the Town by Resolution No. 2015-215 approved Meridia, College Campus Urban Renewal, Dover, LLC's Redevelopment Concept Plan for a College Campus Project Under the Downtown Redevelopment Plan; and

WHEREAS, the Town and the Redeveloper entered into a redevelopment agreement for the Redevelopment Ares (the "Redevelopment Agreement"); and

WHEREAS, the Redeveloper commenced renovation of the existing building and construction of retail space in the first floor and nine (9) residential units on second, third and fourth floor with a first-floor façade improvement.

WHEREAS, in accordance with the Redevelopment Agreement, the Redeveloper has requested the issuance of a Certificate of Completion for the Project and the Town has agreed to the same in accordance with the terms of this resolution and in the Certificate of Completion; and

NOW, THEREFORE, for an in consideration of the representations, covenants and agreements herein set forth and in the Redevelopment Agreement, the Town of Dover does hereby certify that:

- The acquisition, renovation, construction and installation of the Project have been completed by the Redeveloper in accordance with the Redevelopment Agreement, and the plans and specifications applicable thereto. In connection with the foregoing, the Redeveloper has performed all of its duties and obligations under the Redevelopment Agreement and has completed the Project in accordance with the requirements of the Redevelopment Agreement.
- 2. The Redeveloper's construction of the Project was completed.
- 3. The recording of this Certificate of Completion shall constitute a conclusive determination of the satisfaction and termination of the agreements and covenants in the Redevelopment Agreement and in the Redevelopment Plan, with respect to the obligations of the Redeveloper to construct the Project.
