ORDINANCE NO. 28-2017

AN ORDINANCE OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER, COUNTY OF MORRIS, STATE OF NEW JERSEY AMENDING AND SUPPLEMENTING ARTICLE XXVIII OF THE REVISED GENERAL CODE OF THE TOWN OF DOVER ENTITLED "PARKING", CHAPTER G "PROHIBITED PARKING"

WHEREAS, pursuant to *N.J.S.A.*40:48-2, the governing body of a municipality may make, amend, repeal, and enforce such other ordinances, regulations, rules and by-laws not contrary to the laws of this State or of the United States, as it may deem necessary and proper for the good government, order and protection of person and property, and for the preservation of the public health, safety and welfare of the municipality and its inhabitants, and as may be necessary to carry into effect the powers and duties conferred and imposed by this subtile, or by any law; and

WHEREAS, it has been determined by the Mayor and Board of Alderman that the current parking restrictions on Summer Avenue should be amended to promote public safety and welfare;

NOW, THEREFORE BE IT ORDAINED by the Mayor and Board of Aldermen of the Town of Dover, County of Morris and State of New Jersey that Article XXVIII of the Revised General Code of the Town of Dover entitle "Parking, Chapter G, entitled "Prohibited Parking" is hereby amended and supplemented as follows:

<u>SECTION 1</u>. The current restrictions prohibiting parking on Summer Avenue is hereby stricken from the Code. Ordinance 05-1995 is hereby repealed.

SECTION 2. Article XXVII entitled "Parking", Chapter G, entitled "Prohibited Parking" is here by amended and supplement to include:

NAME OF STREET	SIDES	LOCATION

- A. Beginning at 8:00 a.m. on even numbered days until 8:00 a.m. the following day, parking shall be permitted on the north side of Summer Avenue (even numbered homes) beginning at the intersection of South Morris Street to its terminus. Parking is not permitted on the south side of Summer Avenue (odd numbered homes) on these days.
- B. Beginning at 8:00 a.m. on odd numbered days until 8:00 a.m. the following day, parking shall be permitted on the south side of Summer Avenue (odd numbered homes) beginning at the intersection of South Morris Street to its terminus. Parking is not permitted on the north side of Summer Avenue (even numbered homes) on these days.

SECTION 3. Whenever snow has fallen and the accumulation is such that it covers the street, an emergency shall exist and no vehicle shall be parked on Summer Avenue. The above parking prohibition shall remain in effect after the snow has ceased, until the streets have been plowed sufficiently and to the extent that parking will not interfere with the normal flow of traffic.

<u>SECTION 4.</u> The effectiveness of this Ordinance is contingent on signs being erected as required by law.

SECTION 5. Unless another penalty is expressly provided by New Jersey Statute, every person convicted of a violation or provision of this ordinance or any supplement thereto should be liable to a penalty of not more than fifty dollars (\$50.00) or imprisoned for a term not exceeding 15 days or both.

<u>SECTION 6</u>. All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistencies.

SECTION 7. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

<u>SECTION 8</u>. The Ordinance shall take effect in accordance with law.

ORDINANCE NO. 29-2017

AN ORDINANCE BY TOWN OF DOVER CONCERNING THE DOVER POLICE DEPARTMENT AND AMENDING THE CODE OF THE TOWN OF DOVER ENTITLED POLICE DEPARTMENT, "ARTICLE I, ORGANIZATION AND MEMBERSHIP" AND "ARTICLE V, TABLE OF ORGANIZATION".

WHEREAS, the Town of Dover has determined that substantial changes to the organization of its police department are necessary;

WHEREAS, the Town's Mayor and Board of Alderman have reviewed and updated the "Police Department" section of its Code;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Aldermen as follows:

SECTION 1. Chapter 57, Article I, and Article V, of the Town of Dover, County of Morris and State of New Jersey are hereby repealed.

SECTION 2. A NEW Chapter 57, Article I, of the "Code of the Town of Dover", as set forth on Exhibit A attached hereto and made a part hereof, is hereby adopted to set forth the basic structure, powers and duties of the Dover Police Department, and to replace the aforementioned provisions of the "Code of the Town of Dover."

<u>SECTION 3.</u> All ordinances and resolutions or parts thereof inconsistent with this Ordinance are repealed.

SECTION 4. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portion thereof.

SECTION 5. This Ordinance shall take effect upon its final adoption and publication as provided for by law. The provisions of the attached Chapter 57, Article I, shall be applicable within Dover upon taking effect and shall become a part of the new Dover Town Code once completed and adopted.

RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER, COUNTY OF MORRIS AND STATE OF NEW JERSEY AUTHORIZING THE EXECUTION OF AN AGREEMENT WITH ST. CLARE'S EMERGENCY MEDICAL SERVICES FOR MEDICAL DIRECTION AND TRAINING

WHEREAS, the Town of Dover and St. Clare's desire to enter into an agreement for Medical Services and Training; and

WHEREAS, BLS Agency is a New Jersey licensed physician that has the skills and experience to offer training for various emergency medical services and to serve as medical director for basic life support ambulance service providers in New Jersey; and

WHEREAS, BLS Agency is the owner and operator of a basic life support service that is or intends to be licensed as a basic life support ambulance service provider by the New Jersey Department of Health, Office of Emergency Medical Services ("DOH"), and desires for Provider to provide training to certain of its employees and personnel and serve as Medical Director to provide medical consultation, as needed, and medical direction of the administration of the BLS services related to the above indicated programs; and

WHEREAS, this Agreement shall commence on the Effective Date and shall continue for a period of one (1) year; and

WHEREAS, these services will not incur a cost to the Town of Dover; and

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Board of Alderman of the Town of Dover, County of Morris, in the State of New Jersey, that the Mayor and Clerk are authorized to enter into an agreement with BLS Agency for EMT Medical Services and Training.

Brian Gorski—9 Summer Avenue —Mr. Gorski also expressed concern regarding Ordinance #28-2017. He mentioned that he's personally unsure if the day is an odd or even day which would make the new parking rules and regulations difficult to follow. He feels as though the surrounding streets are narrow and need to be enforced as well. Mr. Gorski also mentioned that possibly posting signage for Sunday would be helpful.
