

REGULAR MEETING MINUTES DOVER TOWN HALL 37 N. SUSSEX ST., DOVER, NJ 07801 FEBRUARY 25, 2020

Mayor Carolyn Blackman called the February 25, 2020 Regular Meeting of the Mayor and Board of Alderman to order at 7:03p.m. and read the Sunshine Statement that the meeting was being held in accordance with the Open Public Meetings Act, also known as the Sunshine Law, N.J.S.A. 10:4-6. Notice of the meeting was sent to the Daily Record and Star Ledger on January 4, 2020 and published in the Record and Ledger on January 10, 2020. Notice was also posted on the Bulletin Board in Town Hall. Mayor Blackman also advised that under State Law that there is a no smoking in this public building and asked those in attendance to take notice of the emergency exits in the event of an emergency.

The Mayor then led those in attendance in the salute to the flag. Acting Clerk Schmidt then conducted the roll which resulted in the following:

Following the roll, the Clerk announced that all members of the Governing Body were present and there was a quorum. Also present at the meeting was Acting Municipal Clerk John P. Schmidt and Town Attorney Timothy P. Downs.

REPORT OF COMMITTEES

Alderman Correa gave an update on the Special Committee for Recommending Amendments to Chapter 2 of the Town Code. He said that the committee is working deliberating and replacing sections of the Code and that the committee recently met again for nearly 3.5 hours. He commented that at the latest the committee hopes to distribute the Code for consideration and introduction at the last meeting in March. He thanked Town professionals and employees including Attorney Downs and Clerk Schmidt.

PRESENTATIONS OF COMMUNICATIONS, PETITIONS, ETC.

Mayor Blackman asked Clerk Schmidt to explain the first communication on the agenda. Mr. Schmidt advised the Board as to DCA LGN-2020-02 concerning the 2020 Municipal Cap Referendum Procedures.

The Mayor, Board and those in attendance then heard a presentation from Marvin J. Joss, Partnership Specialist from the New Your Regional Census Center concerning the 2020 U.S. Census. Mr. Joss works for the U.S. Census Bureau within the U.S. Department of Commerce. Mr. Joss spoke about the importance to be counted in the Census, which is important for congressional representation and receiving federal funds such as CDBG and FEMA funds. He stressed that the information collected is secure and is not shared with any other government agency including law enforcement. He also explained that individuals can now respond online. Online responses start March 12 and ends April 27. He also explained that following April 27, census workers will be in the field collecting data and that the jobs are available. They are flexible and are \$21.00 per hour. The Mayor and Board thanked Mr. Joss for the informative presentation. Mayor Blackman asked where people could get information about census jobs, which Mr. Joss explained. Alderwoman Rugg asked if there will be any type of meeting in Dover. Mr. Joss said that if it is not in Dover, it will be nearby. Alderwoman Rugg expressed concern about those who do not drive. They Mayor offered the municipal building as a potential meeting place for a meeting in Dover.

Following the presentation about the Census, Tom Spring from Public Works spoke about the banners from St. Clare's hospital. There was an agreement with the prior administration to put up banners on Blackwell Street. St. Clare's was promised to be put up February 1, 2020. Mr. Spring explained that there is a gap when banners are up between March 20th and May 25th between Winter and the Heroes Banners. The St. Clare's banners are current at Public Works and were delivered in November. Alderwoman Wittner asked how this topic came about. Mr. Spring commented that he did not know. He also mentioned that there would be no cost to put up the banners since DPW would be out there to remove the Winter banners. Alderman Quinones asked if this was advertisement for St. Clare's and how would this impact other businesses. Mr. Spring said that this was the first time for something like this and that usually the banners have been our banners.

Mr. Spring then explained the DPW Generator project. He said that DPW does not currently have a generator and when power foes down there is no backup power, which does not allow the

Town to fuel vehicles including fire trucks. Monies for the generator have been allocated from the capital budget and DPW hopes that the Governing Body will award the contract for the generator to the lowest bidder. He also mentioned that as a result of an energy audit, LED lights were installed in Public Works, which reduced the energy output allowing for a less expensive generator which lowered the expense of the project.

PUBLIC COMMENT ON AGENDA ITEMS ONLY

After reading a statement and procedures for public comment, the Mayor then opened the floor up to the public who wished to make comments on agenda items only. Seeing that no one wished to comment, Mayor Blackman closed the public comment portion on agenda items only.
