# REGULAR MEETING MINUTES DOVER TOWN HALL 37 N. SUSSEX ST., DOVER, NJ 07801 April 28, 2020

Mayor Carolyn Blackman called the April 28, 2020 Regular Meeting of the Mayor and Board of Alderman to order at 7:01p.m. and read the Sunshine Statement that the meeting was being held in accordance with the Open Public Meetings Act, also known as the Sunshine Law, N.J.S.A. 10:4-6. Notice of the meeting was sent to the Daily Record and Star Ledger on January 4, 2020 and published in the Record and Ledger on January 10, 2020. Notice was also posted on the Bulletin Board in Town Hall. Mayor Blackman also advised that under State Law that there is no smoking in this public building and asked those in attendance to take notice of the emergency exits in the event of an emergency.

The Mayor then led those in attendance in the salute to the flag. Acting Clerk Schmidt then conducted the roll which resulted in the following:

Following the roll, the Clerk announced that all members of the Governing Body were present and there was a quorum. Also present at the meeting was Acting Municipal Clerk John P. Schmidt, Deputy Town Administrator Carlos Sanchez, Town Attorney Timothy P. Downs and Chief Licensing Inspector Patrick Laverty.

Mayor Blackman then provided an update since the last meeting on COVID-19. The Mayor reported that as of yesterday, the Town of Dover has 511 cases and 22 deaths. Mayor Blackman commented that we want to lift up the families impacted by COVID-19 in prayer and that our thoughts and prayers are with them.

The Mayor then thanked our first responders, Town employees, members of the Board of Aldermen, healthcare workers and many others for everything they are doing. Mayor Blackman reported that she and other town officials continue to have regular and weekly calls with the Governor's Office as well as the county, St. Clare's Hospital, Zufall Health Clinic, the Superintendent of Schools and Regency Grande among others. She said that it is important to stay informed and how to help each other.

Mayor Blackman also recognized and thanked local churches who have partnered with the Town, as well as the Salvation Army. The Mayor also spoke about the partnership between the Town of Dover and the Table of Hope mobile food pantry, which distributes food on Fridays. Mayor Blackman said that we started with 135 residents and last week, the 3<sup>rd</sup> Friday, over 300 people received assistance. Mayor Blackman thanked everyone in the community who is helping.

After making comments, Mayor Blackman asked for a motion to approve the minutes of April 14, 2020. Alderman Ballesteros made a motion to approve the minutes, seconded by Alderwoman Wittner.

### PRESENTATIONS, MUNICIPAL CORRESPONDENCE

Following the committee report, the Mayor asked the Acting Municipal Clerk to discuss the Municipal Correspondence on the agenda. Acting Clerk Schmidt stated the Town received a letter from Mayor Janice Kovach of the Town of Clinton / 1<sup>st</sup> VP NJ League of Municipalities, which was sent to all municipalities in the Congressional District asking municipalities to contact or write a letter of support for United States House Resolution 6467 to the Speaker of the House, House Minority Leader and the Majority and Minority Leaders of the United States Senate. The letter was also sent out in conjunction with Congressmen Tom Malinowski. Mayor Blackman thanked the Clerk for the explanation and also thanked the Congressmen for advocating for municipalities, including Dover.

The Governing Body then considered the approval of the bill list / Res. 135-2020. Mayor Blackman asked for a motion to approve. A motion was made to approve the bill list and adopt Res. 135-2020 by Alderwoman Wittner, seconded by Alderwoman Rugg.

Both the Acting Clerk and Mr. Laverty explained Res. 136-2020. The Town of Dover is currently part of a consortium of municipalities which purchases electricity. The addendum extends Dover's participation in the program and also will result in a lower rate for those participating, which is also lower than JCP&L. Collectively, residents in Dover who do participate have saved \$30,000 to date.

The Mayor asked for a motion to approve resolutions 136-2020 thru 139-2020. Alderman Ballesteros made a motion to approve Resolutions 136-2020 to 139-2020, seconded by Alderwoman Rugg.

#### **OLD BUISNESS**

The Acting Municipal Clerk reminded everyone that FDS forms need to be filed by April 30<sup>th</sup>. There was a slight extension given but he asked everyone who has not filed to file. He also reported that the Town is about halfway toward full compliance with filing FDS forms. He also reminded members of the governing body about the MEL/JIF Online Course Seminar. For each official who takes the online seminar, the Town receives a \$250 credit. The Acting Clerk thanked Alderwoman Rugg and Mayor Blackman for completing the seminar.

Mayor Blackman then asked if there were any comments from the board. Hearing none, she opened the public comment portion of the meeting and asked if any member of the public wished to speak. Hearing that no members of the public wished to speak, Mayor Blackman closed the public comment portion of the meeting.

In closing the meeting, Mayor Blackman reminded everyone that Town Hall is still operating electronically using email. The Mayor also stated that some business is being conducted via

appointments. Mayor Blackman also reported that a number of residents are still coming to Town Hall to pay water bills. The Mayor also thanked the Board for their efforts during the crisis, the Acting Clerk for his help with meetings and the Deputy Administrator for leading and working with Town employees.

The Mayor also urged people to stay informed and stay home as much as possible, wear masks and be a part of the solution. The Mayor thanked everyone and reminded everyone to stay safe.

Mayor Blackman then entertained a motion to adjourn. Alderwoman Wittner moved to adjourn, seconded by Alderman Correa. On voice vote, 9-0 (Aldermembers Correa, Tapia, Ballesteros, Rugg, Cruz, Valencia, Quinones, Wittner and Mayor Blackman in favor) the meeting was adjourned at 7:34p.m.
