Municipal Clerk Verga stated adequate notice was given to the official newspaper.

Mike Obremski, Area Manager from Jersey Central Power and Light (JCP&L). Mr. Obremski provided some background on his position with JCP&L. He will be involved with the daily operations with the operating team at Richboynton Road so he will be part of the scheduling process. On June 4th, JCP&L will roll-out a First Responder Training course which will run through the County Office of Emergency Management, this course will allow for first aid squad members to receive two CEU's towards their education requirement. Mr. Obremski will be in contact to set up a meeting to identify critical facilities in town and tie them into JCP&L's database. Mayor Dodd thanked Mr. Obremski and looks forward to working with him.

REGULAR MEETING MINUTES May 14, 2013

The Regular Meeting of the Mayor and Board of Aldermen was held in council chambers, 37 N. Sussex Street, Dover, New Jersey.

The meeting was called to order by Mayor Dodd at 7:09 pm

ROLL CALL

Present: Aldermen Visioli, Picciallo, Romaine, Blackman, Rutan, Noriega, Yzarnotegui and Mayor Dodd

Absent: Alderman Downs

Also present were Attorney Isa, Administrator Close and Municipal Clerk Verga

Municipal Clerk Verga stated adequate notice was given to the official newspaper.

Mayor Dodd opened the meeting to the public.

Fred Kantor – 81 Hanover Rd, Mt. Lakes, NJ – Mr. Kantor challenged almost an identical ordinance on abandoned and junked cars in Mountain Lakes and was overturned on many counts. Recently, a similar ordinance was proposed in two towns and their attorneys referenced Mr. Kantor's Superior Court record which was used to advise their council that the ordinance could not be enacted. He noted that the Town of Dover does not have the authority to enact such law. Discussion continued on abandoned and junked vehicles. Mr. Kantor noted that if such ordinance is enacted, he will assist each and every person brought to trial. He wanted to know how a brand new BMW parked in his yard with no license plate affects the health and welfare of the town. He noted that the board of aldermen must have a valid interest in health, safety and welfare.

MAYOR'S REPORT: He expressed that the Town of Dover had a very successful shred day event and noted that 110 residents participated in the event. Mayor Dodd congratulated Alderman Picciallo and the DeShazo family for a very nice dedication ceremony. On Sunday, River Street was rededicated to Reverend Quiles for his service to the community. He reminded the public that on Saturday the Mayor's Fishing Derby will take place at Hurd Park starting at 7:00 am. He expressed that there were a lot of people who donated time, food and prizes for the fishing derby. Mayor Dodd publically thanked Costco for their donation of all the food for the fishing derby. Mayor Dodd noted the dates for the "Youth Empowerment Program" which will take place on May 24th, June 7th and June 24th. He also noted that the first movie night will take place on May 31st at JFK Park.

ORDINANCE FOR SECOND READING

ORDINANCE 07-2013 AN ORDINANCE AMENDING THE CODE OF THE TOWN OF DOVER TO REGULATE UNREGISTERED AND JUNKED VEHICLES

WHEREAS, the Mayor and Board of the Town of Dover has the authority to enact ordinances regulating abandoned, junked, and unregistered vehicles, and finds that this ordinance will advance the health, safety, and welfare of the Town's residents.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Aldermen of the Town of Dover, Morris County, New Jersey, that:

<u>Section 1</u>: Chapter 371 of the Code of the Town of Dover shall be amended to state:

Chapter 371 Vehicles, Unregistered or Junked

§371-1. Definitions. As used in this section:

- A. "Person" means and includes a natural person, partnership, corporation, limited liability company, and business or firm of any other type or form.
- B. "Unregistered motor vehicle" means a motor vehicle designed for operation on the public streets, which is not and has not for a period of 30 days or more been currently registered with, or is without bearing a valid motor vehicle inspection sticker from, the state motor vehicle commission or other agency having jurisdiction to register same, except for motor vehicles stored by new car dealers, used car dealers and motor vehicle repair facilities with current licenses issued by the State of New Jersey and the Town.
- C. "Junked motor vehicle" means a motor vehicle that is not and has not, for a period of 30 days or more, been capable of operation on the public streets under its own power; and further means a vehicle, whether or not so operable, which

is kept and maintained for the purpose of stripping or removing parts therefrom, except for motor vehicles stored by new car dealers, used car dealers and motor vehicle repair facilities with current licenses issued by the State of New Jersey and the Town.

- D. "Enclosed garage" means a fully enclosed building or structure having no means of vehicle ingress or egress other than through an operable door or doors.
- §371-2. <u>Storage Prohibited: Exception for Enclosed Garage</u>. It shall be unlawful for any person to keep, store, or maintain an unregistered or junked motor vehicle in the Town of Dover, except in an enclosed garage.
- §371-3 <u>Presumption of Junked or Unregistered Vehicle</u>. A motor vehicle that conforms to the definitions of Subsection 371-2 (B) or (C) will be presumed to be an unregistered or junked vehicle, as the case may be, subject to rebuttal upon proof of the owner's contrary intentions.
- §371-4. <u>Violations and Enforcement</u>. Any person convicted for a violation of any provision of this Code shall be subject to one or more of the following: a fine of not more than \$2,000, imprisonment for any term not exceeding 90 days, and/or a period of community service not exceeding 90 days. The responsibility for enforcement is with the Police Department.
- <u>Section 2</u>: All ordinances or parts of ordinances that are inconsistent with the provisions of this ordinance are hereby repealed, but only to the extent of such inconsistencies.
- <u>Section 3</u>: The provisions of this ordinance are severable. If any part of this ordinance is declared to be unconstitutional or invalid by any court, the remaining parts of this ordinance will remain in full force and effect.

Section 4: This ordinance shall take effect upon final approval and publication, according to law.

Alderman Visioli has moved the ordinance be adopted and duly seconded by Alderwoman Blackman and passed for second reading by the following roll call vote.

Mayor Dodd opened the meeting to the public for a hearing on ordinance #07-2013.

Fred Kantor – 81 Hanover Rd, Mt. Lakes – Mr. Kantor noted that if a vehicle is in such condition that it harbors vermin, animals, rats, mice, etc. it is indeed a danger to health, safety and welfare and that the statements that he gave are not to pertain to something that is dangerous as such. He noted that if such danger is present then the town would have every right to regulate the law.

WHEREAS, the Town of Dover of the County of Morris, State of New Jersey, has established a Joint Municipal Court serving the Town of Dover, Township of Mine Hill, Borough of Mt. Arlington, Borough of Rockaway and Borough of Wharton under a Shared Services Agreement with the Town of Dover as lead agency; and

WHEREAS, N.J.S.A. 2A:3-5 states the appointment of a Judge of the Municipal Court is to be made by the Mayor with the consent of the Board of Aldermen; and
