# REGULAR MEETING MINUTES JUNE 13, 2017

The Regular Meeting of the Mayor and Board of Aldermen was held in council chambers, 37 N. Sussex Street, Dover, New Jersey.

The meeting was called to order by Mayor Dodd at 7:00 PM

### **ROLL CALL:**

Also present were Administrator Donald Travisano, Attorney Timothy Downs and Deputy Municipal Clerk Tara Pettoni.

Deputy Municipal Clerk Tara Pettoni stated adequate notice was given to the official newspaper.

Mayor Dodd opened the meeting to the public on any agenda items.

**Percy**—116 East Blackwell Street—Owner of Elite Limo & Taxi—Percy expressed concern about the amount of vehicles allowed per company. He also expressed that he is concerned about the enforcement of the "gypsy" taxis and limos in Town. These unlicensed companies are effecting his company as a whole.

**Axel Acevedo**—15 North Salem Street—Owner of Axel's Express Taxi & Limo—Mr. Acevedo expressed his concern regarding the Medical Vehicles with OP license plates that are acting as limousines and being used for arranged fares. He also requested that the Town allow the companies to register an additional 5 taxis which would allow each company to have 20 taxis rather than 15.

**Russ Shattan from MCR and Dan Miller, Chief Investment Officer** from American Hotel & Income Properties (REIT). Mr. Miller briefly spoke about his company. They currently own 95 hotels including their newest purchase of the Hilton Homewood Suites in Dover. They plan on purchasing 13 more hotels in the area.

### AN ORDINANCE OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER AMENDING AND SUPPLEMENTING ARTICLE XXVII OF THE REVISED GENERAL CODE OF THE TOWN OF DOVER ENTITLED "PARKING" HANDICAPPED PARKING "SPACES" BY REPEALING HANDICAPPED PARKING SPACES AT VARIOUS LOCATIONS

#### ORDINANCE NO. 15-2017

## AN ORDINANCE OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER, COUNTY OF MORRIS, NEW JERSEY ESTABLISHING A STOP SIGN ON WHITE STREET AT THE INTERSECTION OF HILLSIDE AVENUE

**WHEREAS**, pursuant to *N.J.S.A.*40:48-2, the governing body of a municipality may make, amend, repeal, and enforce such other ordinances, regulations, rules and by-laws not contrary to the laws of this State or of the United States, as it may deem necessary and proper for the good government, order and protection of person and property, and for the preservation of the public health, safety and welfare of the municipality and its inhabitants, and as may be necessary to carry into effect the powers and duties conferred and imposed by this subtitle, or by any law; and

**WHEREAS**, the Municipal Engineer investigated the limited sight distance at the intersection of White Street and Hillside Avenue within the Town of Dover; and

**WHEREAS**, the Municipal Engineer prepared a report entitled "Investigation of Three Way Stop Condition, White Street at Hillside Avenue" (the "Report") dated May 4, 2017; and

**WHEREAS**, pursuant to *N.J.S.A.* 39:4-8(b)(1) the Town of Dover is permitted to designate any intersection as a stop intersection and erect appropriate signage if the intersection is located within 500 feet of school without the need for approval from the New Jersey Department of Transportation; and

WHEREAS, the intersection is located less than 250 feet from Dover High School; and

**WHEREAS**, the Report sets forth the Municipal Engineer's professional opinion that in the interest of safety and the expedition of traffic on the public highways, that a stop sign be erected on westbound White Street at its intersection with Hillside Avenue, thereby creating an All Way Stop at the intersection; and

**NOW THEREFORE, BE IT ORDAINED** by the Mayor and Board of Aldermen of the Town of Dover, County of Morris and State of New Jersey as follows:

- 1. Pursuant to *N.J.S.A.* 39:4-8b(1)c, there is hereby established a stop intersection on White Street at its intersection with Hillside Avenue. The proposed stop sign shall be located on westbound White Street at its intersection with Hillside Avenue.
- 2. There shall be installed signage and markings at the intersection of White Street and Hillside Avenue. Specifically, the required signage and striping shall be installed as set forth on the plan entitled "Signage & Marking for White Street & Hillside Avenue" prepared by the Municipal Engineer and annexed to the Report.
- 3. This ordinance shall be submitted to the Municipal Engineer and he shall, under his seal as a licensed professional engineer, certify to the governing body of Dover that the sign and its placement have been approved by the engineer after investigation of the circumstances, and that it appears to the engineer to be in the interest of safety and expedition of traffic on the public highways and conforms to the current standards prescribed by the manual of the uniform traffic control devices for streets and highways as adopted by the Commissioner of Transportation, all as required by *N.J.S.A.* 39:4-8.
- 4. All ordinances or parts of ordinances inconsistent with this within ordinance are hereby repealed to the extent of such inconsistencies.
- 5. If any section, subsection, sentence, clause, phrase, or portion of the ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.
- 6. This Ordinance shall take effect upon passage and publication as provided by law.

#### RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER ACTING AS THE REDEVELOPMENT ENTITY CONSENTING TO TRANSFER FROM MCRS DOVER, LLC TO AHIP NJ DOVER PROPERTIES LLC

**WHEREAS**, the Mayor and Board of Aldermen of the Town of Dover acting as the Redevelopment Entity adopted a resolution at a special meeting held on Thursday, December 2, 2010 consenting to the transfer of Lot 1.05, Block 901 (the "Property") from Briad Lodging Group Dover, LLC, hereinafter "Briad," to MCRS Dover, LLC, hereinafter "MCRS" and approving designation of MCRS as the redeveloper for the Property; and

WHEREAS, Briad conveyed title to the Property to MCRS; and

**WHEREAS**, pursuant to a Redevelopment Agreement between the Town of Dover and MCRS, MCRS succeeded to all the obligations of Briad and its predecessor in title, Woodmont Dover ET, L.L.C., with regard to the redevelopment of the Property; and

**WHEREAS**, MCRS desires to transfer title to the Property to AHIP NJ DOVER PROPERTIES LLC ("AHIP Properties") and AHIP Properties desires to lease the Property to its affiliate AHIP NJ DOVER ENTERPRISES LLC ("AHIP Enterprises"); and

**WHEREAS**, transfer and leasing of the Property requires the consent of the Mayor and Board of Aldermen pursuant to the covenants set forth in the Deed dated October 5, 2005 and recorded October 14, 2005 in Deed Book 6462, Page 192, in the Office of the Clerk of Morris County, New Jersey; and

**WHEREAS**, AHIP Properties and AHIP Enterprises and their parent company, American Hotel Income Properties REIT Inc., have submitted financial information, operational information, and the history of their experience in the hotel industry.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Board of Aldermen of the Town of Dover acting as the Redevelopment Entity, County of Morris, State of New Jersey as follows:

- 1. Consent to the transfer of the Property from MCRS to AHIP Properties and the lease of the Property by AHIP Properties to AHIP Enterprises is hereby granted on the following conditions:
  - a. AHIP Properties must execute a Developer's Agreement and Maintenance Agreement in substantially the same form as currently exists between the Town of Dover and MCRS which agreement has additional parties that own Lots 1.03, 1.04 and 1.06 of Block 901 and provides for maintenance of the public street known as Commerce Center Drive through an existing association formed by the owners of Lots 1.03, 1.04, 1.05 and 1.06; and
  - b. AHIP Properties must agree to assume all obligations of the redeveloper to the Town of Dover under all redevelopment documents and agreements, upon which MCRS shall be released from all obligations and liability thereunder arising from and after the date thereof.
