ORDINANCE(S) FOR SECOND READING AND PUBLIC HEARING

ORDINANCE NO. 25-2007 OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER AMENDING AND SUPPLEMENTING ARTICLE 28 A "PARKING" OF THE REVISED ORDINANCES OF THE TOWN OF DOVER, 1969 SAVED FROM REPEAL

BE IT ORDAINED by the Mayor and Board of Aldermen of the Town of Dover, County of Morris and State of New Jersey as follows:

- 1. Article 28 A entitled "Parking" is hereby amended and supplemented to permit parking on both sides of the street on East McFarlan Street between Conger Street and Perry Street except that there shall be no parking on the south side of East McFarlan Street beginning at a point at the southeasterly curb line intersection of East McFarlan Street and Jackson Avenue continuing in an easterly direction a distance of 265 feet which described area is hereby designated as a school bus pick up and discharge area.
- 2. This ordinance shall become effective upon the approval by the Commissioner of the Department of Transportation of the one-way designation of East McFarlan Street between Conger Street and Perry Street.
- 3. All ordinances or parts of ordinances inconsistent with this within ordinance are hereby repealed to the extent of such inconsistencies.
- 4. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions

hereof.

5. The Ordinance shall take effect in accordance with law.

BE IT ORDAINED by the Mayor and Board of Aldermen of the Town of Dover, County of Morris and State of New Jersey as follows:

- 1. Article 38, entitled "Streets, Gutters and Sidewalks, Chapter G, entitled "One-Way Streets" of the Revised Ordinances of the Town of Dover, 1969, Saved from Repeal under the Code of the Town pf Dover is hereby amended and supplemented as follows:
- A. East McFarland Street is hereby established as a one-way street eastbound between Conger Street and Perry Street. This ordinance shall take effect upon approval of the Commissioner of the New Jersey Department of Transportation.
- 2. All ordinances or parts of ordinances inconsistent with this within ordinance are hereby repealed to the extent of such inconsistencies.
- 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.
 - 4. The Ordinance shall take effect in accordance with law.

WHEREAS, the governing body of the municipality believes:

- it is in the public interest to accomplish such purpose; and (a)
- said purpose of improvements for the health, welfare, convenience or betterment of the (b) betterment of the inhabitants of the Municipality; and
- (c) the amounts to be expended for said purpose or improvements are not unreasonable or exorbitant; and
- (d) the proposal is an efficient and feasible means of providing services for the needs of the inhabitants of the Municipality and will not materially impair the credit of the Municipality, substantially reduce its ability to pay punctually, principal and interest on its debts nor reduce its ability to supply other essential public services and improvements, nor will it create an undue financial burden to be places upon the Municipality,

NOW, THERFORE, BE IT RESOLVED by the Governing Body of the Municipality that:

- (1) The applicant of the Local Finance Board is hereby approved.
- (2) The Clerk of the Municipality is hereby directed to prepare and file a copy of this resolution with the Local Finance Board.
- (3) The Local Finance Board is hereby respectfully requested to consider such application and to record Its approval as provided in the Local Bond Law.

RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER AWARDING THE BID FOR THE SEARING STREET ROADWAY AND IMPROVEMENTS SMALL CITIES GRANT PROJECT TO ARNOLD'S ROADS, INC.

WHEREAS, the Town of Dover received a Small Cities Grant for the Searing Street Road and improvement project; and

WHEREAS, the Town of Dover solicited for bids for such project; and,

WHEREAS, ten bids were received by the Town on August 8, 2007; and

WHEREAS, the municipal engineer has reviewed the bids; and

WHEREAS, the four lowest bidders of the ten are as follows:

A. Jenicar Builders Contractors, Co., Inc. \$274,490.00
B. Arnold's Roads, Inc. \$302,155.00
C. A & J Contractors Group, Inc. \$302,900.00
D. Tomaro Contracting Co., Inc. \$305,000.00; and

WHEREAS, all of these estimates were below the municipal engineer's estimate of project costs; and

WHEREAS, Jenicar Builders Contractors Co., Inc. by letter dated August 13, 2007 directed to the municipal engineer advised of a major error in its calculations of its bid price having mistakenly set forth a unit price of \$5.00 a square yard for concrete when it was meant to be \$50.00 per square yard for item # 14 and in item #15 mistakenly inserting \$6.00 a square yard when it should have been \$60.00 a square yard resulting in an error of \$68,400.00; and

WHEREAS, Jenicar Builders Contractors Co., Inc. has asked to be released from its bid due to this obvious error; and

WHEREAS, the municipal engineer has recommended that such bid be rejected as not responsible due to the clerical error; and

WHEREAS, Marvec Construction Corporation had indicated a total contract price of \$280,530 which would then make it the next low bidder but was incorrect in its calculated bid price in accordance with the

specification which, if correctly calculated would have been in the amount of \$421,300.00, in excess of the low bidder; and

WHEREAS, the municipal engineer recommends that the Marvec Construction Corporation bid be rejected as not responsible due to the miscalculated summary price; and

WHEREAS, the municipal engineer has recommended the lowest responsible bidder to be Arnold's Roads, Inc. in the amount of \$302,155.00 and that Arnold's Roads, Inc. be awarded the contract for the Searing Street Roadway and Improvements Small Cities Grant Project; and

WHEREAS, this award is to be subject to the approval of the Department of Community Affairs;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Board of Aldermen of the Town of Dover, County of Morris and State of New Jersey as follows:

- 1. Arnold's Roads, Inc. is hereby awarded the bid for the Searing Street Roadway and Improvements Small Cities Grant Project in the amount of \$302,155.00;
- 2. This award is subject to approval of this bid by the New Jersey Department of Community Affairs under the Small Cities Grant Project;
- 3. Jenicar Builders Contractors Co., Inc. is hereby released from its bid obligation due to the obvious substantive errors in its bid;
- 4. The municipal attorney is hereby authorized to draft a contract and the Mayor and Clerk are hereby authorized to execute such contract for the award of the bid as set forth above.

WHEREAS, the tax collector needs authorization from the governing body to eliminate the collection on the over-assessed amount as to each lot;

- 2. The tax collector is hereby directed to only collect the amount of taxes for Block 1904, Lot 10.01 as shown on the 2006 judgment with a total assessment of \$311,500.00 and any other amount due which are in error are hereby waived.
