REGULAR MEETING MINUTES September 22, 2009

The Regular Meeting of the Mayor and Board of Aldermen was held in council chambers, 37 N. Sussex Street, Dover, New Jersey.

The meeting was called to order by Mayor Dodd at 7:25 pm

Clerk Verga stated adequate notice was given to the official newspaper.

Mayor Dodd opened this portion of the meeting to the public for agenda items only.

<u>MAYOR DODD</u> – Mayor Dodd commented that he has been working with the Engineering Department and Administrator Close concerning renovations for King Field Complex. Mayor Dodd expressed that Home Depot will be sponsoring the work on the concession stand. He noted that a lot of detailed plans are being drafted for the entire complex of baseball fields. He expressed that they are very excited to host a "Team Depot" project in the Town of Dover and noted that it will be a community event. Mayor Dodd asked Alderwoman Blackman to report on the Hispanic Heritage Month Celebration which was hosted by Morris County Prosecutor's Office Community Affairs Unit on which she attended.

<u>ALDERWOMAN BLACKMAN</u>- commented that the Hispanic Heritage Month Celebration which was organized by Detective Keisha Higgs from the Morris County Prosecutor's Office. She noted that the event was well attended and well organized. She commented that Guadalupe Correa of Dover St. Clare's Hospital Health System, Reverend Luis Carrasquillo of Dover & Morristown and Sgt. Richard Gonzalez were recognized.

Mayor Dodd congratulated Sgt. Gonzalez. He reminded the board that Regency Grande will be hosting a BBQ event on Sunday, September 27, 2009.

ADMINISTRATOR CLOSE – Mr. Close thanked the Department of Public Works (DPW) and Code Enforcement for their assistance with the maintenance needed on foreclosed properties in town. He congratulated Capt. Ugalde who graduated from the FBI Academy. He stated that Don Constanzo, Health Officer and Nurse Patricia Merritt are prepared to assist with the swine flu vaccinations; also our OEM Office headed by Scott Warner is also ready. He noted that King Field Baseball Complex plans are coming to fruition.

<u>ATTORNEY PENNELLA</u> – Attorney Pennella noted that the last phase of the taxi case is coming up, he is confident that the town will be successful. He noted that tax appeals are in the discovery process.

ALDERMAN POOLAS – Alderman Poolas commented that "Poppa Son" from Don's Cleaners on Bassett Hwy. and Warren Street has passed away. Alderman Poolas asked the board to check the internet for complaints on Global Reach International and expressed that if the complaints are true then it's an organization that the town shouldn't support. Alderman Poolas noted that at 11 River Street there's a refrigerator on the porch with the doors still on. Mayor Dodd asked Mr. Close to have the street sweeper go through River Street.

RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER <u>AUTHORIZING SURVEYING SERVICES FOR THE RECONSTRUCTION OF</u> KING FIELD COMPLEX, BALL FIELD RECONSTRUCTION

WHEREAS, the Town of Dover is in need of engineering/surveying services; and

WHEREAS, Keller & Kirkpatrick, Inc. 301 Gilbraltar Drive, Suite 2A, Morris Plains, NJ 07950 can provide Professional Engineering/Surveying Services needed for the reconstruction of King Field Complex, Ball Field Reconstruction; and

WHEREAS, such agreement would be exempt from the public contracts law as it is below the bid threshold pursuant to N.J.S.A. 40A:11-3; and

WHEREAS, the cost of the service to be acquired is below the \$17,500.00 threshold of the "Pay to Play" law, N.J.S.A. 19:44A-20.4 *et.seq.* and therefore exempt from its requirements; and

WHEREAS, the services required are specialized requiring expertise in Engineering and Surveying services rendering this an extraordinary, unspecifiable service; and

WHEREAS, the anticipated term of the contract is six months; and

WHEREAS, Keller & Kirkpatrick, Inc. has submitted a proposal dated September 21, 2009 indicating that they will provide the service for the lump sum of \$16,800; and

WHEREAS, Keller & Kirkpatrick, Inc., although not required, has completed and submitted a Business Entity Disclosure Certification certifying that they have not made any reportable contributions to a political or candidate committee in the Town of Dover in the previous one year, and that the entry into the contract with the Town of Dover will prohibit them from making any reportable contributions through the term of the contract; and

WHEREAS, the Chief Financial Officer certifies that there are sufficient funds to make this award;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Board of Aldermen of the Town of Dover, County of Morris and State of New Jersey as follows:

1. The Mayor and Board of Aldermen hereby authorize the entry into a contract with Keller & Kirkpatrick, Inc. for engineering and surveying services.

RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER AUTHORIZING THE AWARD OF A NON-FAIR AND OPEN CONTRACT FOR INTERPRETER/TRANSLATOR FOR THE DOVER JOINT COURT

WHEREAS, the Town of Dover has a need to acquire Interpreter/Translator Services as a non-fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.5

WHEREAS, the CFO has determined and certified in writing that the value of the acquisition will exceed \$17,500; and

WHEREAS, the anticipated term of this contract is one (1) year; and

WHEREAS, Leda C. Gonzalez has submitted a proposal indicating she will provide the service for \$145.00 for a two hour minimum court session and \$60.00 for each additional hour needed; and

WHEREAS, Leda C. Gonzalez has completed and submitted a Business Entity Disclosure Certification which certifies that she has not made any reportable contributions to a political or candidate committee in the Town of Dover with the Mayor and Board of Aldermen, in the previous one year, and that the contract will prohibit Leda Gonzalez from making any reportable contributions through the term of the contract; and

WHEREAS, the CFO has certified that funds are available for this award – N.J.A.C. 5:30-5.4.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Board of Aldermen of the Town of Dover authorizes the Mayor and Municipal Clerk to enter into a contract with Leda C. Gonzalez as described herein; and

BE IT FURTHER RESOLVED, that the Business Disclosure Entity Certification and the Determination of Value be placed on file with this resolution.

BE IT FURTHER RESOLVED, the appointment as Interpreter/Translator for the Town of Dover is made without competitive bidding as it is a "professional service" under the provisions of the Local Public Contracts Law, because attorneys are a recognized profession, licensed and regulated by law.

MARIBEL GARLAND – 138 Oram Drive – She invited that board to the Halloween event at Hooey Park. She explained that there will be a costume contest and parade. Alderwoman Blackman commented that a resident will lead the event. Alderman Blackman commented that the wood fencing at Hooey Park was painted by the Mayor's Assistance Program and the fire hydrants will be painted in the upcoming days. She noted that they will help the Department of Public Works with the clean-up at Hooey Park.

<u>WARREN DARNULC</u> – 151 Grant Street – Asked if board members read the minutes before voting on same. Mayor Dodd answered yes. He then stated that minutes should be prepared soon after the meeting and he doesn't feel they are prepared soon enough if at the 9/22/09 meeting the board is approving minutes from the 9/08/09 meeting. Mayor Dodd explained the minutes are prepared and the clerk e-mails them to board members for review and a resolution is prepared for the next meeting. Clerk Verga stated minutes do not become official until the Mayor and Board approves them and that, cannot be done until the next meeting.
