## PLEDGE OF ALLEGIANCE was recited by all.

## CALL TO ORDER:

Chairwoman Denise Ridner called the meeting to order at 7:05pm as follows:

## PUBLIC PORTION

MOTION: To suspend the regular order of the Meeting and open this portion of the meeting to the public made by: Commissioner Robin Foster
SECONDED BY: Vice Chairman Tom Iwicki
ALL IN FAVOR MOTION CARRIED.
Cathy McCall of Dover Recreation Traveling Basketball discussed turning the gym over to Dover Little League on March 16, 2009. Her last game is on March 15, 2009 and she will relinquish use of the gym to Dover Little League. She gave Board members a copy of her schedule. She also explained that she has only been able to field one team due to not being able to find coaches for other teams. Chairwoman Denise Ridner asked if she had considered putting an ad in the paper to get coaches. Cathy said she was not aware she could do that. Tom Iwicki said criteria needed to be established to set up teams and tryouts need to be advertised. The purpose of the teams should be to feed the next age group for the following year. Cathy discussed the expense involved in fielding a team, the league fees are $\$ 1500.00$ per team. She said she has tried repeatedly to get coaches, but no one wants to step up. Chairwoman Ridner said the Commission does appreciate her coming to the meeting and explaining her program to the Board.

Nancy Hagerich from the Senior Committee gave a short report on her Senior Citizen Meetings and said next year they will not begin until March, due to weather issues, turnout is low over the winter months.

Chris Jaeger from Dover Strikers Soccer discussed the applications for gym time. She said they have 17 teams: 7 Travel and 10 Recreation Soccer Teams. She said opening day is April $5{ }^{\text {th }}$ for Travel and April $18^{\text {th }}$ for Recreation Soccer. She asked the Board to consider allowing them at least one gym. Commissioner Gori questioned the feasibility of fielding 17 teams with limited gym and field space. A discussion about the sport in season being Little League ensued. Chairwoman Ridner said all the sports will be evaluated to determine how many children can be accommodated for each sport, not just Soccer. A total number of participants will be determined, and when the sport reaches capacity, enrollment will be closed, and children will be able to try other sports. Victor Rodriguez said he would check with Little League to see if any of the gyms could be given over to Soccer for practice. He will contact Anna Bocchino or Chris Jaeger to let them know, so an application can be made to the Board of Education to switch the use to Soccer.

Patrick Fahy of 2 E. Chrystal St asked Luis Acevedo about funding which was to have been set aside to put turf on the small soccer field. Luis said the funding is not there. He will put clay on the field to level it off for the spring season.

Sylvio Marin of Club Colombia spoke about his application for use of Crescent Field Complex for the Colombian Festival on Saturday, July 18, 2009. He agreed to abide by the terms of last year and additional stipulations as outlined by the Town Administrator.
Alderwoman Carolyn Blackman said she noticed a lot of garbage on the side streets around the festival area, which need more attention this year. Mr. Marin said he would make sure the side streets were cleaned as well.

Jody Marcus of the Dover Community Children's Museum came to speak about Rediscover Dover Day. She said she was excited to hear about plans for an event like this, and would like to offer her assistance. She suggested changing the name to Discover Dover Day, which would be much more positive. She said that "Rediscover" makes it sound negative and we want to send a positive message. Chairwoman Ridner said she liked the idea and thanked Jody for coming to the meeting and offering to help. She said the Committee will set up a meeting and invite Jody to attend within the next week or so.

Wayne Patterson stated he was a volunteer basketball coach from the Mine Hill Basketball Program and discussed an incident that occurred at a basketball game at East Dover School gym on Thursday, January 29, 2009. He explained his side of the events that occurred prior to the police department being summoned to the gym. He wanted something to be done to the other coach involved in the incident which he named as Cathy McCall. He said he could provide letters from Mine Hill coaches and parents in his defense.

Cathy McCall spoke in her defense, explaining her version of the events of the evening of January $29^{\text {th }}$.

After listening to the confrontation on both sides, Chairwoman Ridner stated we need to hear all sides. She asked both coaches to put in writing what happened, and any one else who may have witnessed the incident may submit in writing a statement regarding the event. She said we do not
want to have issues between Mine Hill and Dover when we have worked so hard to have a good relationship with Mine Hill Recreation.
Denise asked Alice to get a copy of the Police Report from the incident for the Commissioner's to review.

Carl Rossi, DPW Director was introduced to Recreation Chairwoman Ridner and the Commissioners by Luis Acevedo. Carl apologized for having to leave the meeting. He said he will be working diligently on evaluating the parks and fields and will keep the Board informed.

DISCOVER DOVER DAY COMMITTEE: Chairwoman Denise Ridner appointed the following committee, including herself as Chairwoman, Commissioners Robin Foster \& Peter Gori, Alderwoman Carolyn Blackman, Alice Gilbert, Secretary. Denise said she would contact Alice with a date to set up meeting to begin working on the event and to contact Jody Marcus and ask her to attend.

## Chairwoman Ridner reviewed the following applications with Commissioners:

## Use of Facility Applications:

1) Sylvio Marin of Club Colombia has applied for use of Crescent Field Softball Field \& Second Street Side \& Basketball Court on Saturday, July 18, 2008 for the Colombian Festival from 8:00am to dusk. Approximately 2000 to attend. Approval was granted last year with a list of conditions which Mr. Marin was required to meet for final approval. The conditions were as follows:
2) Mr. Marin was required to provide proof of certification of legitimate security personnel hired in addition to seven (7) Dover Police Officers.
3) Advertisement was limited to local sources only.
4) Protective storm drain covers were provided and no grease to be poured on property.
5) A safety meeting was held in the Mayor's office to go over Health, Fire \& Safety issues with respective departments at least two weeks prior to the event: (Fire, Police, DPW \& Health).
6) A $\$ 2500.00$ Bond was posted with the Treasurer two weeks prior to the event.
7) Eighteen Port a johns must be provided - two must be handicapped accessible.
8) 2 Dumpsters must be provided. (Copy of contracts for dumpsters \& Port a johns to be submitted to Recreation)
9) Dumpsters \& Port a johns must be removed the day after the event.

## Town Administrator McDougall has reviewed the above application and added the following stipulations:

1) Sylvan Way must be kept clear for emergency vehicle access.
2) The number of private security personnel must be approved in advance by Police Chief Valentine.
3) If tents are used, they must be certified and approved by the Fire Prevention Officer, Marty Reynolds, prior to the event.
4) Junior Carmona of 59 Randolph Ave, Dover, NJ has applied for use of King Field Complex from June 29 thru July 17, 2009 from Monday thru Friday, from 9:00am to 2:00pm for Back To Basics Baseball Camp. Alice has been working to find a new location. Nancy Hagerich's group has been moved to the Dover Historical Society Building. The other group is much larger and has cancelled meetings for this week. The owner of Spruce Street Complex said he would get back to Alice by Friday to let us know if a room could be secured in the Spruce Street Complex Building. The Heritage Room which was built for meetings has been used as a storage room. Both Sacred Heart \& Millpond Towers have turned down our request to use their facilities. The court room at Town Hall has been secured for a business meeting for the Dover Senior group on Monday from 10am to 12:00noon in case they do not find a place before then. The First Presbyterian Church is trying to work with them, but need to get approval from the Board at the Church.

## Meeting with DHS Athletic Director
